A. MOST SERIOUS ALLEGED CURRENT OFFENSE

- 12 Points Homicide; Attempt 1st Degree Murder; Agg. Kidnaping; Any Offense with a Firearm; Home Invasion; Heinous Battery; Agg. Criminal Sexual Assault; Criminal Sexual Assault; Armed Robbery; Armed Violence; Agg. Vehicular Highjacking; Agg. Arson; Drug Manufacture/Delivery on Public Housing or School Grounds; Obstructing Justice where Juvenile ID Cannot be Determined; and any other Class X felony.
- 10 Points Residential Burglary; Agg. Criminal Sexual Abuse; Kidnaping; Arson; any Drug Offense which is a Class 2 or greater; and any other Class 1 Felony.
- 8 Points Burglary; Agg. Battery; Agg. Domestic Battery; Agg. Stalking; Theft/Possession of Stolen Motor Vehicle; Compelling Gang Membership; and any other Class 2 Felony.
- 6 Points Agg. Assault; Robbery; Criminal Sexual Abuse; Extortion; Felony Mob Action; False Fire Alarm/Bomb Threat; and any Drug Offense which is a Class 3 Felony.
- 5 Points Felony Offenses Related to Motor Vehicle, Burglary of Motor Vehicle; Unlawful Restraint; Forgery; and Resisting Arrest.
- 4 Points Theft Over \$300; Retail Theft Over \$150; Criminal Damage to Property Over \$300; Misdemeanor Domestic Battery; Misdemeanor Battery; any Drug Offense which is a Class 4 Felony; and any other Class 3 Felony.
- 3 Points Unlawful Use of a Credit Card; Obstructing Justice; and any other Class 4 Felony.
- 2 Points any other Misdemeanor offense.
- 0 Points Status Offenses
