**SUPPLEMENTAL ORDER  
IMPRISONMENT IN COUNTY JAIL**

Defendant has been found guilty and sentenced to a term of imprisonment as set forth in the Judgment Order to which this Order is attached.

**IT IS, THEREFORE, FURTHER ORDERED**, as follows:

**I. Determinate Term of Imprisonment.** Defendant is sentenced to \_\_\_\_\_ days/months in the \_\_\_\_\_ County Jail.

**II. Periodic Imprisonment – Weekends.** Defendant shall serve

D. Defendant shall complete an Affidavit of Employment and Income and shall pay \$\_\_\_\_\_ per day for his board during the term of the periodic imprisonment which will be paid from his earnings as required by Paragraph E.

E. Defendant shall on each pay day turn over all/a portion of Defendant's earnings to the Circuit Clerk to be distributed for the following purposes in the following order:

- 1. To pay to \_\_\_\_\_ County all fines, restitution, and costs owed by the Defendant;
- 2. To pay to \_\_\_\_\_ County all costs of the Defendant's board during this term of periodic imprisonment;

3. To pay to Defendant the necessary travel expenses to and from work and other incidental expenses of the offender;

4. To pay to the dependents of Defendant for the necessary family expenses.

F. Defendant shall immediately notify the Sheriff and the Circuit Clerk of any loss or change in employment during the term of this periodic imprisonment and shall complete a new Affidavit of Employment Income.

G. Defendant shall execute a release of information form authorizing the Sheriff, Probation Officer and Circuit Clerk to obtain satisfactory evidence of the Defendant's employment, pay records, or attendance at \_\_\_\_\_.
